L is for love. There are many different degrees of love, but it all comes back to basic respect and affection for our neighbors. We can feel love more strongly as we do for family members and our life partners, or we can love less personally by showing courtesy to a passer-by in the form of a smile or wave. To love others, it has been said, that we must first love ourselves. To love oneself implies that we accept and treasure our lives and all they have to offer. When we use the term unconditional love, we imply that the object of our love and cherishing can do the



most hideous of acts and we will still extend our love and affection to that individual. Doesn't it make sense that we set the example for the rest of the world by loving EVERYONE unconditionally? To love one person unconditionally is easy, but is it as easy to love everyone we come in contact with?

The most extraordinary ex-

amples of unconditional love were shown to me last month during a trip to Arkansas, of all places. My sister's husband was killed while riding his motorcycle down a winding road. He was in his lane negotiating a curve, when a 20-year-old woman in a Ford Explorer reached into the back seat to return a pacifier to her baby's mouth and crossed the centerline killing my brother-in-law instantly. Becky and I rushed out to Eureka Springs, Arkansas to be with my sister and the rest of my family. At the memorial service, the funeral, the interment, and at every other opportunity, my sister stood up with a smile on her face and prayed for the woman who killed her husband. "... so she may see our unconditional love for her and allow her to feel our forgiveness," was my sister's plea with God. My initial reaction was shock. How could my sister forgive this careless woman so soon? I was angry, wasn't everyone in the room angry too? How could anyone forgive this woman not even a week after she killed my brother-in-law?

Then that it came to me: Treat everyone as you want to be treated. Love everyone as you want to be loved. Anger and hatred won't bring back my brother-in-law, or stop Fred Phelps, or change the marriage laws. The only thing we can do is love everyone we meet. Love them with forgiveness, love them with a smile and a wave, love them with a "Hello," or love them with kindness - just love them!

but some. Mine were primarily at work and Don's were also from his job but narrowed down to one in particular. She was a charting secretary at the Hospital where he worked. I have remained friends with her and her daughter for a span of almost 40 years now.

Friends. How do we define them? For me it is as simple as a sixth grader, when the teacher asked her student, "What is a friend?" A beautiful answer came forth. "A friend is someone I like," a simple and all encompassing definition.

We had very few friends outside of our families. Gertrude, the lady with whom Don worked and her daughter are the two oldest. As our antique

business progressed, we made friends with fellow antique dealers and a couple of customers.


Our relationship was such that we were whole within ourselves. I know that may sound odd but that is the way it was.

After our 36 year relationship ended with his death over 4 years ago, I was left with little direction. The friends that I had were well meaning but did not have a clue as to what I could do to put my life back together.

Time passed. I joined Perceptions. I healed. Although you wouldn't know it today, I was an introvert back then. To this day, I still get nervous when I'm by myself in social outings.

Along the way, I have made a number of friends through Perceptions.

The first and probably the most important one greeted me at my first General Meeting with a hug.

A few months later at a Meet and Greet in Bay City a fellow antique dealer, whom I'd never met before, asked if he may sit with me. I had seen him as he came in and was intrigued. My answer was, "If you don't, I'll break your legs." We talked antiques and yes now he is one of my best friends.

When Don and I were together we had almost no outside friends, and now I can safely say I have at least 40 and counting. The worth of these multiple friends has been incalculable. They have given me direction in my life and helped me make major decisions, advising me to sell my huge house and move to a new location, discovering a new life and living it for all that it's worth, seeking a new partner, and not feeling sorry for myself.

One of the major decisions that is solidifying in my head is not moving out of state. The longer I contemplate it and the more friends I make, the less I think I want to relocate. Of course, circumstances alter situations and only time will tell where I'll finally end up.

After a long struggle, I have found peace within myself. I am reminded of the lyrics to a song I used to sing years ago. "When you're worried and you can't sleep, count your blessings instead of sheep and you'll go to sleep counting your blessings." Don't make me sing it for you.

We're discriminated against, judged by everyone, and we have to overcome just being ourselves. All of those things make us transgender people better leaders, more empathetic.



June 2008 Marks Turning Point for Transgenders

On June 16, 2008 the American Medical Association passed a resolution at its annual conference in Chicago calling for "public and private health insurance coverage for treatment of gender identity disorder (GID) as recommended by the patient's physician." The resolution clearly states that the AMA recognizes the body of medical research that demonstrates the effectiveness and medical necessity of established

treatments, such as hormone therapy and surgery, and rejects the myth that these treatments are "cosmetic" or "experimental."



tions. Many transgenders are denied access to proper care and treatment because they are cost-prohibitive. Hormones, electrolysis, and a variety of reconstructive surgeries can potentially add up to tens of thousands of dollars.

"America's physicians," says Mara Keisling, Executive Director of the National Center for Transgender Equality (NCTE), "are saying that transgender people, like all others, deserve competent medical care based on what individual doctors and their patients determine is healthiest for each person. Doctors and patients, not insurance companies, should be making those choices."

Transgenders are also being heard in Washington. On June 26, 2008 the Health, Employment, Labor, and Pensions subcommittee of the Committee on Education and Labor held a hearing on "An Ex-

amination of Discrimination **Against Transgender Americans** in the Workplace."

Subcommittee Chairman Rep. Rob Andrews (D-NJ) said in his opening statement that the purpose of this historic hearing was to "educate Congress and the public about the discrimination transgender Americans face particularly in the workplace absent a federal law to protect them."

"Workplace discrimination against a particular group of people is morally unacceptable and con-

> flicts with the values we hold sacred in our society. Furthermore, workplace discrimination, unchecked, harms our economy both domestically and globally,"

said Andrews.

Approximately 700,000 to 3,000,000 transgenders in America run the risk of being fired, demoted, or turned

away from employment because of their transgender identity. Witnesses at the hearing included a retired U.S. Army colonel and a top aeronautics engineer who faced employment discrimination because of their transgender status.

Today, there are 12 states, along with the District of Columbia, that have transgender employment protections in place. Many companies have also adopted these policies. Despite this, says Rep. Andrews, "studies and surveys reveal high rates of unemployment and low-income status among transgender Americans."

Pioneering GLBT Activist Retires from U of M

James Toy, Diversity Coordinator for the University of Michigan's Office of Institutional Equity, retired on July 1, 2008. A campus-wide celebration of Jim's historic career is being planned for this fall. Jim started his career at U of M as the Co-Founder and Co-Coordinator of Michigan's Lesbian, Gay Male

Bisexual Programs Office (now the Spectrum Center) in 1971. Jim served in that capacity for twenty-three years before joining what is now known as the Office of Institutional Equity in 1994. During Jim's incredible thirty-seven year tenure at Michigan, he served on countless committees, including more recently

Voices of the Staff and the Health System's Pride Network. He is a founding member of several community groups and has served on many associations, including City of Ann Arbor HIV/ AIDS Task Force (1993-1997); AFSC Inclusive Justice Program Committee (2000); Washtenaw HIV/AIDS Coalition (2004); and the Washtenaw Faith Action Network (2004), just to name a few. His contributions include work on a variety of boards during his long and distinguished career, including service as a Delegate & Alternate, State Board of Directors, American Civil Liberties Union of Michigan (1985-1994); and member, National LGBT Concerns Committee, National Association of Social Workers (2006). Through Jim's tireless efforts and dedication, the University, our state and the nation are more welcoming and supportive for everyone. Jim has been a long-time friend of Perceptions and his work has been greatly appreciated.
