# Perceptions/PFLAG Annual Chocolate Party March 14th By Tim A.



### For the Bible Tells Me So



Saginaw Valley will celebrate PRIDE with a dinner, program and recognizing local LGBT and allies who have served our community.



# **Saginaw's Historic Homes**

If you want to know anything about the history of Saginaw's South Jefferson Avenue district, Tom Trombley is the guy to ask. At our February meeting, Tom presented us with a detailed history of the area and of Saginaw itself, noting that Saginaw was originally 2 separate cities, Saginaw and East Saginaw, which were consolidated as one in 1889. In fact, at one time, Saginaw was Michigan's 3rd largest city.



It was wonderful to see photographs of some of Saginaw's historic homes as they were when they were first constructed. While the details of each home Tom described cannot be done justice in this small space, if you go to <a href="www.saginawlibrary.org/jeffersonavenue">www.saginawlibrary.org/jeffersonavenue</a>, you can see first-hand some of the historic homes that were detailed for us. Tom had many stories of the era during which these houses were constructed and how they evolved over time into what they are today. Slides accompanied his description of many of the structures on South Jefferson and it was interesting to see and hear about the homes many of us pass by every day without really knowing the stories behind them.

It seems a natural extension of Tom's talk that perhaps someone would be interested in organizing a walking tour of the South Jefferson Avenue district once nicer weather makes an appearance. ## **Corvino/Stanton Debate Gay Marriage at SVSU**

John Corvino, gay Wayne State philosophy professor, and Glen Stanton, conservative analyst from Focus on the Family, discussed, "Same-Sex Marriage: A Civil Debate," before 150 people at Saginaw Valley State University on Feb. 3rd. SVSU hosted the first Corvino/Stanton debate in 2004 - many of us were there.

Corvino and Stanton addressed issues other than gay marriage: same-sex parents, gay adoption, discrimination, domestic benefits, marriage as a civil rights issue and more. While they disagree passionately about most issues, over five years they have formed an interesting - maybe bizarre - friendship.

Stanton says gay marriage is just a cultural experiment and "no gay-gay relationship is deserving the same as heterosexuals." It is unequivocally wrong; children need a mom and dad, he said.

Corvino has become a same-sex marriage advocate nationally and argues that same-sex marriages would "promote happy, stable and loving relationships." Locally, Michigan's same-sex public employees and children have lost health insurance through Michigan's 2004 one-man and one-woman marriage amendment. These are unhappy, unstable and unloving realities for same-sex families. It is wrong.

Most in the audience were pro-Corvino, especially in the in the questions and answers session. He probably resonates the future in same-sex marriage in society.

### **Transgenders Meet with SVSU, GSA Group**

On January 28th, volunteers from Perceptions spoke with students of the <u>Gay-Straight Alliance</u> at Saginaw Valley State University. Speakers Erin Moers and Terri Jackson held an open discussion with students to further understanding of what it is to be Transgendered.



Moers and Jackson explained that transgenderism is not based on sexual orientation as is the common misconception, but rather the desire to have one's body match how they perceive themselves to be. In this desire there are many degrees of transition which can occur, solely dependent upon the individual. Transition is when one changes their outward appearance to be consistent with who they are. This is done to not only "look like" either a male or female, but to be perceived and recognized by others for who they truly are. Transition can occur at any age, but nearly all transgendered people know there is something wrong at a very young age.

Issues between transgendered persons, main-stream society, and even the various groups within their own community were discussed. The intent of this meeting was to inform and educate others in the community of who transgendered people are. Feedback from the GSA members was quite positive overall.

## This Doug's Life

**Perceptions has** 

been a God send.



I am the youngest of five sons born to second generation Americans Hazel and Leo Solosky. When my grandparents came to America from Europe, they like so many, entered America by way of Ellis Island. Our name was originally spelled, Szalkowski. His wife was Ida Clump. Grandpa Ignatius was Polish and grandma was German.

The men doing the processing were little more educated than the immigrants entering the county. Thus our name was shortened to: Soloski. My father never liked the "i" and arbitrarily changed it to a "y." The whole family followed his lead. I learned many years later, the change was made because Pa thought the "i" meant we were Jewish and as it turned out to my chagrin, he was prejudice not only against Jews but also against Blacks.

This fact was brought home to me one day when my father spoke some derogatory epithets about Jews. My mother scolded him and said, "Leo, don't say that in front of the kids."

My childhood was typical. I played with my twin and my older, by two years, brother. My oldest brothers, Bill and Richard, 15 and 11 years older than I, were busy with their lives and paid little attention to me.

My twin and I learned to play the piano. I also took voice lessons and played the alto saxophone. To this day, I take great solace in my music. I still play the piano several times a week and listen to classical music almost daily. They are a great way for me to release pent up emotions.

I am a sober alcoholic. I started drinking on a regular basis when I was eleven. My father owned a grocery store and with 5 sons, it was not uncommon to have beer in the refrigerator. I averaged 2 bottles of beer a week and by the time I was a senior in High School, I was drinking a case of beer a weekly. This led to great consternation for my mother.

I hit bottom in my early thirties after experiencing

D.T's (Delirium-Tremors). I was lying in bed. I thought I was awake. As I looked up, I could see what looked like the blades of a ceiling fan descending toward me. The 'sky' was lite yellow. As I watched in fascination, I could hear the sound of the blades as they kept coming closer and closer. I was mesmerized. Closer and closer they came. I became frightened and tried to move, but couldn't. I was becoming scared. I began to panic. I could not move! I remember crying out. That woke me. It was afternoon and the sun was shining. I had sweat the outline of my body into the bed. Shortly after that, I voluntarily admitted myself into Saint Luke's Hospital, Ward A (for alcoholics) for 10 days.

I was also in A.A. for about 5 years but did not stop drinking until I was 34. That is when I met Don. To this day, I am unclear how that came to pass. I sur-

mise that my faulty memory is due to a form of alcoholic black out. Somewhere in the recesses of my mind I faintly remember a judge being involved. I was sent, for what reason I don't know, to

his house. I spent the night and the next morning when I left for work, I saw him watching me as I backed out of his driveway. His expression was that of gentleness and need. That is when I fell in love with him. We were together for the next 36 years.

I have often heard the question, "When did you know you were gay?" I have pondered it for years and concluded that I don't know. I was just me. When I was a kid, the word "gay" meant happy.

I must have suspected there was something different about me when as a teenager my mother said, "Boy you kids (my twin and I) are queer." I remember being scared. As a teen, I had been 'experimenting'. I thought, "Oh God, I've been discovered." I felt so guilty.

Actually, she only meant we were different.


I have always been attracted to males but for the most part was too afraid to do anything about it.

### This Doug's Life

When I graduated from High School, I didn't even go to my senior prom. Instead, I drove around in my used 1951 Pontiac and drank beer.

The only time I was with a man was when I'd pick up a hitch hiker. It is said, "God protects idiots, fools and drunks." Of the numerous men I picked up, I had no bad experiences and the number of times I drove while drunk are legion.

I remember driving on what I thought was the road. It was at night. I had blacked out and was in fact driving on the median that separates the road lanes. I was first on my side and then on the other side which was the wrong way on a one way. Cars were blowing their horns and flashing their lights in anger. I came out of my stupor, realized what I was doing. "Oh shit!" and tore ass out of there. At the time, I didn't equate that with, "Dumb ass, you need help!"

My life with Don came to a tragic end on January 12, 2004, when I found him dead on the dining room floor. My world had come to an end. He had been suffering from strokes and heart problems for 6 years. I had gone to the eye doctor and stopped on my way home to buy some coffee creamer. Something told me to get home. I thought it won't take long. The floor fell out of my life.

I asked our doctor if my presence would have made any difference. He said no, Don's health was such that nothing could have been done.

Perceptions has been a God send.

You can't change unless you want to. I wanted to. I have entered the 21st century kicking and screaming. I now have a computer and dish T.V. Both new learning curves.

There will never be another Don. Although I have gotten used to his passing, I still remember our life together



and sometimes cry a little.

Four years ago, I was a sad introspective man. Our relationship was our life. Now I'm out more, accepting life as new and looking forward to tomorrow.

Strange how things change. After Don died, I tried to do as he and I had always done: maintain the house, yard, business, keeping in touch with his relatives and seeing to my 'children,' the cats.

That is when I realized how much he really did. The business became too much for me and the yard got completely out of hand. I closed down the business and had the yard redone. By doing that, I have more free time and the yard work has been cut in half.

Although I have my place up for sale, the truth is I'd much rather stay here. It's not meant to be. The upkeep is too high.
